# Keeping Children Safe 2023

Updates:

- Children Absent from Education
- Emphasis on Online Safety
- Protected Characteristics and reasonable adjustments

### Filtering and Monitoring







Filtering: Filters out inappropriate or unsafe content when Young people are using the digital world at school or on school devices, when at home or out of the academy

The DSL has overall responsibility for Online Safety, Filtering and Monitoring



Monitoring: Alerts are sent to the DSL, so that they can ensure children are safe.



#### **Governors Questions**

What are you doing to support children with EBSA? What is the academy's safeguarding response to children absent from education? How many children do you currently have in this category?

How are you educating children to prevent them being criminally exploited? If I asked your staff, would they be able to tell me how to spot the signs of CCE? Do you have many children who have been exposed to CCE? Which agencies are you working with to resolve this issue?

How often do you audit the response to Smoothwall notifications? Who is responsible for acting on Smoothwall notifications? Are there any patterns or trends forming and how are you tackling this?

> Does you attendance/ behaviour/ bullying or child on child abuse data show that any children with protected characteristics are adversely affected? What are you doing to tackle this?

# Keeping Children Safe 2023

Reminders:

- Out of School Settings Checks must quality assure that safeguarding procedures are in place & Staff concerns for anyone working in an OOSS on your school site should be reported to the LADO
- HR: Duty to inform candidates of online checks, Copies of documents used to verify the successful candidate's identity, right to work and required qualifications should be kept on their personnel file & Documentation around allegations of Sexual Abuse for staff should be kept until pensionable age or 10 years after the allegation, whichever is longer#
- Children with EHCP's must have an EHCP review if parents are electing to home educate

## Safeguarding Culture


Ensuring a holistic, young people centred, approach
